Appendix 2A - RANDOM SAMPLE SURVEY - ANALYSIS and REPORT

Introduction

An important part of the consultation program was a random sample survey of Strathroy-Caradoc households. The sample was created by selecting every 12th 'Residential Occupied' entry on the Municipality's assessment roll. This method ensured randomness because it is not possible to predict in advance who the 12th entries will be. It also ensured that all parts of the Municipality had the opportunity to participate in accordance with the share of total households in the Municipality. In effect, this methodology creates a survey of owner-occupied households, of which Strathroy-Caradoc contained 7385 at the time of the 2021 Census.

That selection procedure yielded a list of 800 names and addresses to whom was mailed:

- An invitation to participate in the survey
- A two-page questionnaire
- Instructions for completing and returning the questionnaire
- A postage-paid return envelope

These packages were mailed during the week of February 5, 2024, to all 800 invitees (2 were returned undeliverable); responses were received by mail until March 6, 2024. A digital response option, using an access code unique to each invitee, was also offered; 40 responses were received digitally. The questionnaire was limited so that 10 minutes would typically be required to respond. All responses were anonymous.

The total response - i.e., the final sample - was 222 households, 40 digitally and 182 by return mail. A very noteworthy 28% of the 798 invitees responded. The Consultants are very grateful for the time and thoughtfulness displayed by these generous citizens.

(A copy of the questionnaire is included at the end of this report).

Statistical probability

Unlike a survey which is open to all who might choose to opt in, the results of a random sample survey offer a measure of statistical probability that the responses will accurately reflect the responses that would have been obtained from the total of all 7385 owner-occupied households, had all households been asked and responded.

The margin of error helps us determine how much we might be off in our estimate that the sample's answers would completely reflect the answers that all households would have given. For example, a 95% confidence level means a 95% chance that the value is contained within the margin of error. Given a random sample of 222 out of 7385, the margin of error is 6%. That sample size would give us 95% confidence that the numerical responses are within 6% above or below what the total of all 7385 households would have yielded.

Sample Characteristics

Had all 798 randomly selected invitees responded, the responses would also have been representative of all geographic and age elements of the 7385 Strathroy-Caradoc households. Since 222 members of the random sample chose to respond, inevitably the characteristics of that 222 (in terms of residence location or age, for example) correspond less closely with the characteristics (as determined by the 2021 Census) of all households. The table below compares the characteristics of the sample with those of the "real world" as per the 2021 Census.

(Note that the Census does not report separately on the community of Melbourne; therefore, we have combined Melbourne responses into those for the rural area. Also note that, since only 3 households reported in the "under 30" age group, we have combined them with the 30-54 age group.)

In summary, the sample corresponds reasonably well in terms of respondent location (Mount Brydges, Rural/Other, Strathroy). Among those who chose to respond, the rural invitees are "under-represented" to some extent and this fact might influence the total response to a small extent.

Of greater concern is the gap between the percentage of the age groups in the sample and the percentages in Strathroy-Caradoc as a whole. In the sample, the under-55 age group is significantly 'under-represented' while the older age groups are 'over-represented'. We were concerned that this characteristic of the sample could skew the reliability of the results.

In order to address this concern, for three questions we isolated the responses of the under-55 respondents, gave them a double weight (i.e., double -counted them), and added those double responses to the responses from the 55 + age groups. This methodology has to live with the assumption that a second group of 64 under-55 respondents would answer in the same way as the real 64 answered. Nonetheless, In our opinion, this new hypothetical sample of 286 constitutes a more solid reflection of the priorities and concerns of Strathroy-Caradoc households.


In this Report, we have used these Age-Adjusted results for the three questions about Infrastructure Priorities, Importance of Quality-of-Life Contributors, and Community Safety Concerns. The original results of those three questions from the sample of 222 are included in the appendix.

Infrastructure Priorities (age-adjusted)

We asked the question:

Strathroy-Caradoc faces many very expensive demands for renovation, replacement, or expansion of infrastructure and facilities. Please indicate the THREE (and ONLY THREE) criteria that, in your opinion, should be Council priorities for the next 3 years.

The chart below provides the age-adjusted results:


Seldom are survey results a surprise. Not surprisingly, roads and water/wastewater are the community's highest priorities. Infrastructure that facilitates economic growth ranks highly (this perspective benefitted from the age adjustment to affect the priority of under-55 more accurately households). Infrastructure related to police service, fire service, and arena/indoor recreation is also much in mind.

Contributors to Quality of Life (age-adjusted)

We asked the question:

People are moving here: our quality of life in Strathroy-Caradoc is a winner. Below are several approaches to maintaining and improving our quality of life. How important do you consider each to be (1 = most important, 4 = least important)

Again, not surprisingly, medical services (doctors, clinics, Hospital) are almost unanimously considered the most important contributor to the community's Quality of Life.


Indoor and outdoor recreation facilities and activities, community events (fair, festivals, markets), and the availability of rental units and affordable lots are all also considered important factors in community well-being.

Community Safety Concerns (age adjusted)

We asked the question:

Part of Strathroy-Caradoc's attraction is its safe lifestyle and sense of well-being. Looking ahead, how worried are you about any of the following (1=very worried, 4 = not worried).

Drug use and addictions is clearly the foremost concern related to community safety, followed closely by homelessness and threatening behaviour (although homelessness in itself is more than a community safety issue). 9-1-1 response times and theft incidents are also significant concerns.

Municipal Customer Service

We asked the random sample whether in the past year they had made a request to the Municipality. 75 said 'YES'; 143 said 'NO'. (a few evidently chose not to answer).

Of those who said yes, we asked: 'what did you think about the time it took to get a response?' The result:

The Municipality's customer service received neither complete condemnation nor glowing praise. There is room for improvement.

Police Service

We asked how often respondents had interacted with the Strathroy-Caradoc Police Service Police in the past year. 157 reported having had no contact; 61 reported 1-5 contacts' 1 person had had more than 5.

Of those who had had one or more contacts, we asked: 'how would you rate your experience?' The result:

We asked how often respondents had called the 911 emergency call centre in the past year. 178 had not called; 40 had called.

Of those who had called, we asked: 'how would you rate your experience'?'

Clearly, the Police Service, and emergency services in general, are held in very high regard by Strathroy-Caradoc households.

Finally, we asked: 'What is your opinion of the level of visibility of the police service in the community?'

A sizable minority of Strathroy-Caradoc households would like to see the Police Service out and about more often.



APPENDIX 2B -WRITE-IN RESPONSES FROM RANDOM SAMPLE

Introduction

The first question asked in the Random Sample household survey (February 5, 2024 - March 6, 2024) to which 222 of the 798 invitees responded, was:

"1. If there were JUST ONE THING that the Municipality could do THIS YEAR to improve our community, what would that ONE THING be?"

We have often used this question as a way to elicit people's "TOP OF MIND" thoughts and concerns. Being an open-ended question, responses naturally cover a wide range of topics and vary from individual to individual. They can range from very specific (truck turnings at the intersection of Second and Wright) to very general (more road work), and from terse (fix sidewalks) to lengthier anecdotes. Furthermore, they may fit into the traditional municipal "wheelhouse" (roads, development approvals) or not (library programming, more/better restaurants). Nonetheless, all responses reflect what is on people's minds when thinking about their community.

The primary value of the responses is to determine which "top of mind" concerns are most commonly shared. After reviewing all responses, we have grouped similar concerns based on frequency of mention as follows:

A (largest font, red) = 10 or more mentions

B (next largest font, purple) = 6-9 mentions C (smaller font, green) = 3-5 mentions

In addition, so as not to lose the numerous other concerns and ideas that were less frequently mentioned, we have (in the smallest font) listed them under "Other".

Notes

- 1. The risk with this form of analysis is that, despite the large font, it is tempting not to give the large groups their due. Despite the small font, the eye is drawn to the individual entries under "Other". Remember that, for example, the line "A An underpass or overpass under/over the railway tracks in Strathroy" encompasses 11 different people who, each in their own way, expressed this concern. Similarly "C- Address Homelessness" represents the concerns of 4 people, not just one.
- 2. Being an open-ended write-in question, this question invites responses very much based on the often-recent experiences of the individual respondents. As noted

elsewhere, older age groups were "over-represented" among the 222 respondents. Thus, the concerns of older age groups may be over-represented to some extent.

INFRASTRUCTURE and ASSETS

A - An underpass or overpass under/over railway tracks in Strathroy

Illustrative Quotes

Start planning a way forward for a railway overpass/underpass. The situation as it is for emergency responders is not acceptable anymore for a community of this size.

Strathroy needs an overpass or underpass at least one railway crossing - Fire, Police and 911 response times to the hospital are being affected.

It is very frustrating trying to travel north and south through town when trains are either stalled or moving very slowly causing massive back-ups and congestion

C – Tar and Chip Rural Roads

Illustrative Quotes

Put a 5-10-year plan together to finish chipping roads

Tar and chip Troops Road and many other well traveled back roads- We rake up several wheel barrels of gravel every year off our lawn!!!

C - Caradoc Street South

Illustrative Quotes

Get rid of the traffic obstructions on Caradoc St. between Front St. and Metcalfe St. East to allow traffic flow as well as make snow removal easier

I like the side lanes on Adelaide Rd. in Mt. Brydges. That would work well on Caradoc St.

Other

- > intersection of Melbourne Rd and Glendon Rd
- improve drainage on rural roads
- > Stop sign at the corner of Maitland Terrace, Hwy 81 and English Street
- Speed bumps on Moffat lane...a school zone.
- > safety at the corner of Wright Street and Second Street. This corner is becoming increasingly congested as more businesses move into the area, and while it is a commercial/industrial area of town with heavy transport truck traffic, the road is not designed to support this use safely
- Install traffic calming measures on Park, Southfield and Burns streets

- Rumble strips on the edges Mount Brydges to encourage people to slow down and not drive 80 kph through town. Glendon Drive and Adelaide especially
- Plough snow in a way that does not create drifts at the end of driveways
- Speed of traffic on Hull Road
- Level the tracks in Mt Brydges and Strathroy
- > speed and volume of traffic on Parkhouse Drive between Troops and Glendon is very dangerous. Change speed limit to 60.
- Better streetlighting
- the lane markings on Second Street. The turning lane being used as a passing lane.Solid lines please for westbound traffic
- Make Canaan St. a dead end. Close off exits from Muffler man parking lots and the funeral home.
- rim the roadside trees and fire lane trees., especially those around above-ground wires, to help prevent power outages

B - Repair Sidewalks and trails

Illustrative Quotes

Repair sidewalks - I use a walker and use the sidewalks between McKellar - Carroll West - Adelaide St. back to McKellar. I have fallen several times. Keefer is especially bad.

The Municipality should be ashamed of the sidewalks in Mt. Brydges. They are broken and heaved up. At least fix those on the main street.

Replace downtown brick sidewalks. They are a dangerous tripping hazard especially for seniors and those with mobility issues

Other

- > Snow removal from sidewalks in all areas of the Municipality
- > Sidewalks from Collins Way to connect near Walmart
- > barriers at the train crossing should cross the sidewalk too.
- > Improve pedestrian access to conservation area
- More crossing locations in Strathroy on 81.

Indoor pool....I've heard so many people asking for this, and I agree, it would be something I'd get out and use.

C - New Mt Brydges arena

Illustrative Quotes

Mt. Brydges community needs a new community complex (indoor rink, library, lounge hall for events. etc.) The acceptance of a building design and the development of a timeline to complete the project should be done this year.

Other

- Continue to support cultural facilities around town
- > Give teenagers more to do; give them alternatives to drugs
- More activities in Mt Brydges
- More programming for seniors, better publicized
- > Affordable recreation programs for youth
- More free activities in the parks for kids
- Create more family-friendly events
- > Renovate Mt. Brydges arena Put the funds toward renovation instead of building new
- Keep all municipal buildings open to use for senior citizens during inclement weather, summer and winter
- More programs for adults to do in the evening

B – Trees: Plant, Conserve, Care for

Illustrative Quotes

We are losing so many trees in town whether cutting down for personal reasons or growth. Along the stream behind Food Basics, all trees falling into water. Please start planting and please take care of them.

Make the main street of Mt. Brydges more appealing by planting and maintaining trees in the downtown area

Other

- > Clean out the river valley and provide more public success
- Clean out the Reynolds drain and others in the township
- > clean up garbage that people throw out along the ditches. Check up on dead end roads where people throw out junk and debris
- > Yard waste curbside pickup, Once a month in spring & summer, twice/month in fall
- Popen the dam. As the pond silts up and becomes increasingly shallow the elevated water temperatures give rise to huge algae bloom unsightly, smelly, and damaging to the ecology of the river. B – Grocery Store and other commerce in Mt Brydges

Illustrative Quotes

Mt Brydges has grown to the point where it should be able to support a small grocery store similar to the "No Frills" in Glencoe. It is important to match the rate of commercial uses with the rapid residential growth

Put in place a plan that draws interest and provides appropriate incentives for various types of businesses (in particular, a grocery store, restaurants and other important services) to establish themselves in Mount Brydges

Appendix 2C- Strathroy--Caradoc Community Open Survey 2024 Analysis and Report

In addition to the Random Sample Survey, a digital version of the survey was made available to any Strathroy-Caradoc resident who wanted to participate (and had the digital means to do so, as it was on-line only). Residents were notified about this opportunity to participate through news releases and social media and were able to participate either through the link in the notices or by entering the link into their browsers.

An open survey such as this cannot claim statistical reliability in relation to the Municipality's population as a whole, a fact which should be borne in mind when interpreting results. In addition to the ease of participation digitally, its value lies in its openness to any individual wishes to engage in the Municipality's strategic planning process. Typically, it is also an avenue for a younger age groups to participate (the Random Sample Survey was aimed at households rather than individuals).

The table above compares the location and age characteristics of the Open survey respondents to the location and age characteristics of the Strathroy- Caradoc adult population as a whole. It shows that the input of Mt Brydges residents is more heavily represented than its proportion of the Municipality's total adult population. Similarly, the proportion of 30-54 age group respondents is larger than its proportion of the total adult population. As noted above, an opt-in survey was not expected to be, and was not, representative of the whole adult population.

That being said, 1355 people took this opportunity to participate in the process. This is over 7% of Strathroy-Caradoc's total adult population. Truly a striking level of engagement, with results worthy of note on that basis alone!


(Note: This additional survey was not part of the MSPA scope of work and was added at the request of the Municipality.)

Each following page of this report summarized in chart form the responses to each question.


INFRASTRUCTURE and ASSETS




